

**COMPARISON OF TOURIST ARRIVALS BY COUNTRY OF RESIDENCE**  
**APRIL 2009 AND 2010**

Stay-over visitor arrivals for April 2010 numbered 41,357 representing a decrease of 3,920 or 8.7% when compared to April 2009. There were decreases in the Canada, U.K., Germany, Other Europe, Trinidad & Tobago and Other Caricom markets of 403 or 5.7%, 2,548 or 16.1%, 123 or 20.7%, 288 or

16.3%, 396 or 15.9% and 785 or 14.3% respectively. The U.S.A. and Other Countries recorded increases of 569 or 5.5% and 54 or 3.0% respectively. Cruise Passenger arrivals for April 2010 were 69,961 representing an increase of 12,089 or 20.9% when compared to April 2009.

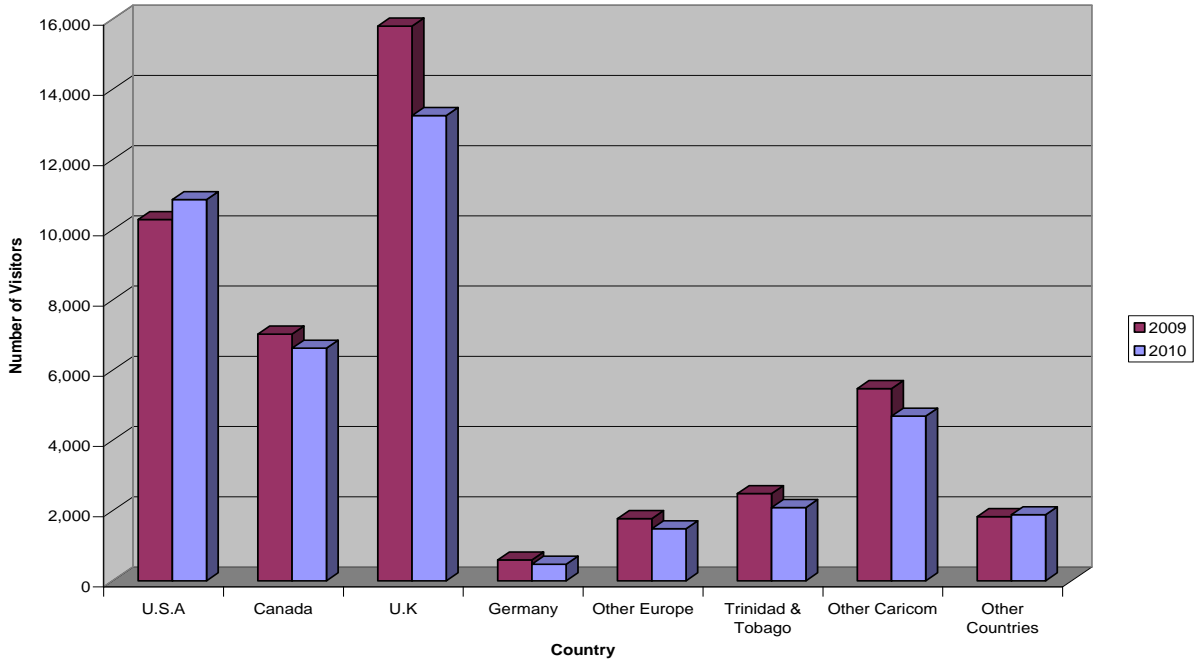

**JANUARY TO APRIL 2009 AND 2010**

Stay-over visitor arrivals for the period January to April 2010 was 189,848. This represented a decrease of 959 or 0.5%. The U.S.A., Canada, Germany and Other Countries markets increased by 10,018 or 26.6 %, 3,440 or 10.5 %, 72 or 2.8 % and 240 or 3.3% respectively. The U.K, Other Europe, Trinidad and Tobago and Other

Caricom markets recorded decreases of 12,454 or 16.8 %, 112 or 1.2%, 495 or 6.2 and 1,668 or 8.7% respectively.

Cruise passenger arrivals were 329,425. This represented an increase of 11,400 or 3.6 % when compared to the corresponding period in 2009.

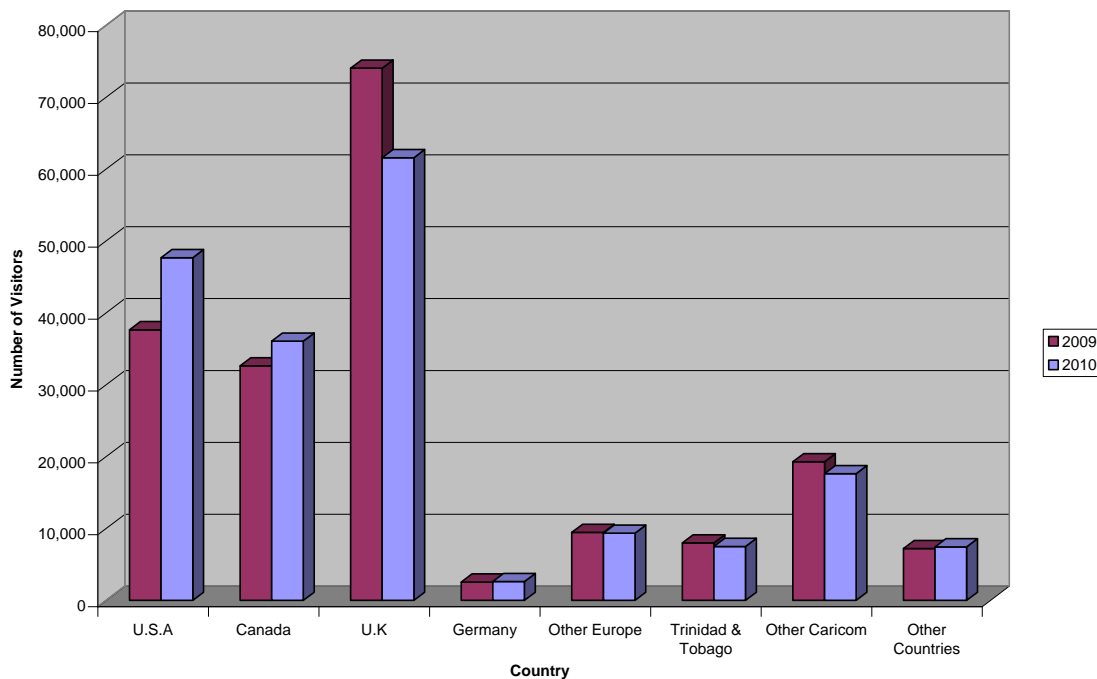
