

COMPARISON OF TOURIST ARRIVALS BY COUNTRY OF RESIDENCE
MARCH 2009 AND 2010

Stay-over visitor arrivals for March 2010 numbered 51,570 representing an increase of 1,333 or 2.7% when compared to March 2009. There were decreases in the U.K., Trinidad & Tobago and Other Caricom markets of 4,460 or 21.5 %, 195 or 9.3 % and 339 or 6.9 % respectively. The U.S.A.,

Canada, Germany, Other Europe, and Other Countries recorded increases of 4,445 or 48.3%, 1,530 or 17.6%, 110 or 16.5%, 132 or 6.4%, and 110 or 5.9% respectively. Cruise Passenger arrivals for March 2010 were 94,470 representing an increase of 10,379 or 12.3 % when compared to March 2009.

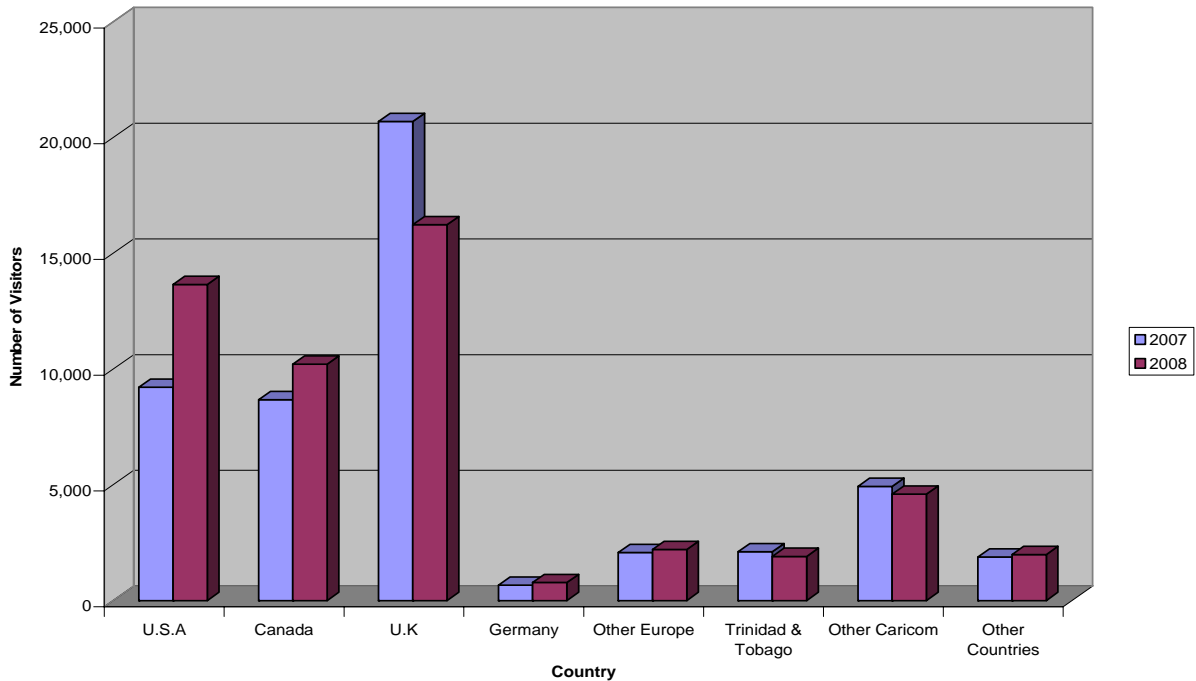

JANUARY TO MARCH 2009 AND 2010

Stay-over visitor arrivals for the period January to March 2010 was 148,491. This represented an increase of 2,961 or 2.0%. The U.S.A., Canada, Germany, Other Europe, and Other Countries markets increased by 9,449 or 34.5%, 3,843 or 15.0%, 195 or 10.0%, 176 or 2.3% and 186 or 3.5% respectively. The U.K, Trinidad and

Tobago and Other Caricom markets recorded decreases of 9,906 or 17.0%, 99 or 1.8% and 883 or 6.4% respectively. Cruise passenger arrivals were 259,464. This represented a decrease of 689 or 0.3% when compared to the corresponding period in 2009.

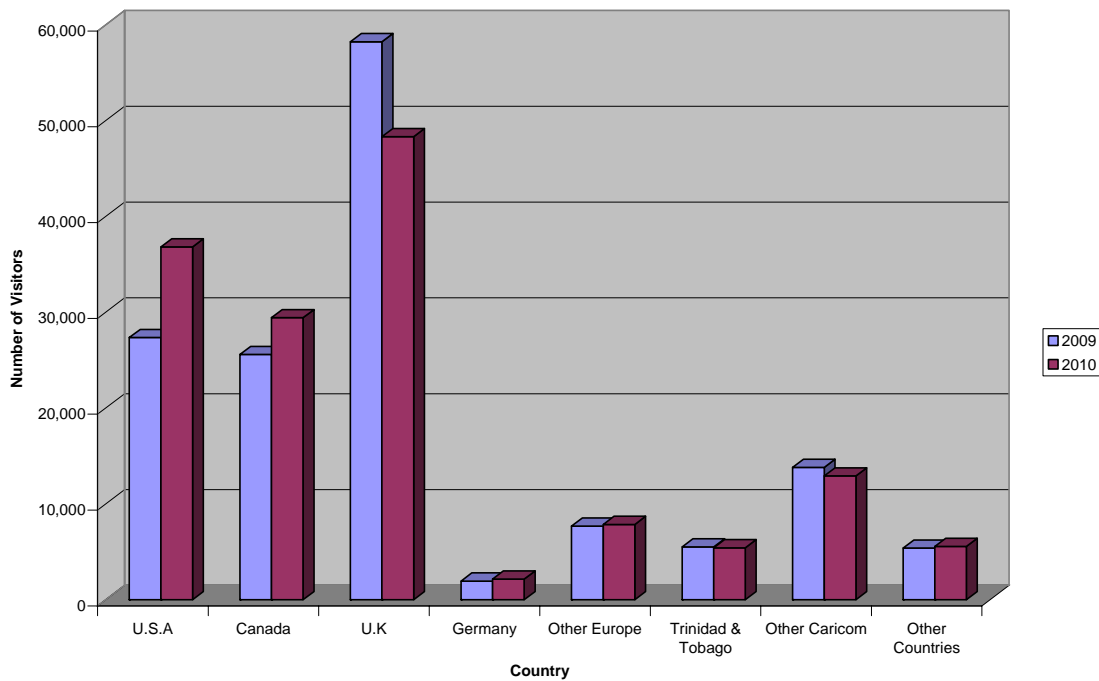
